Regular Board Meeting  
July 25,2025

Chairman Smith called the meeting to order.

Roll Call noted all board members, and the clerk/treasurer were present.

The pledge of allegiance was said.

Motion to approve the agenda was made by Supervisor Woehler, with a second from Supervisor Stebane, all in favor and the motion was carried.

Motion to approve the meeting minutes for June 27, 2025 & July 11, 2025 made by Supervisor Stebane, with a second from Supervisor Woehler, all in favor and the motion was carried.

A family wants to donate to the cemetery. Discussed were monuments addition or plaques. Discussion to hold off until money is donated to decide what to do. Motion to postpone made by Supervisor Woehler, with a second from Supervisor Stebane , motion carried.

Chairman Smith stated that the town is not currently with an agreement with the Forestry Service Agency. Being in agreement will help with road maintenance of forest roads. We need to update contact information. Motion made by Supervisor Woehler to through with the agreement. With a second from Supervisor Stebane, all in favor and the motion carried. The agreement was signed by Chairman Smith.

Discussion on cemetery sign. Supervisor Woehler and Clerk/Treasurer Smith will put something together and present for the next meeting. Motion made by Supervisor Stebane to table it, with a second from Supervisor Woehler and the motion was carried.

A motion was made by Supervisor Stebane to add public guest password to the internet for the town hall. A second from Supervisor Woehler and the motion carried.

The roads are being graveled and graded. Brush was cut on Morgan Lake Road. Holes were filled in on memory lane. There were washouts. Chairman Smith stated that we have the 550 back and they cut the drive shaft and got fuel pump.

The fire department helped with an atv accident on Halls Creek Road. They attended a parade on July 4<sup>th</sup>. They did pump testing with the Goodman fire department. Insurance information needs updating. Chief Sternhagen will get the clek/treasurer a price and equipment list.

Clerk/Treasurer Smith discussed how WPS would like to know when there is a road project projection, The storm damage appeal went through, and we have an extension to file all necessary information and to date this has been done. Supervisor Woehler and Clerk/Treasurer Smith worked on this together. Also discussed were the need to update rules for governing the cemetery. She is working on different aspects of elections and the budget. Deposits for June were \$12,829.42 and balance was \$342,989.42. Checks cleared were \$36,341.24.

Supervisor Woehler made a motion to pay the bills, with a second from Supervisor Stebane , motion carried.

Mike Milan said the town is doing a good job and the roads look good.

Jeff Sternhagen stated they need an application for two gatherings. Marty Kerker asked about fluorescent bulbs.

Supervisor Woehler made a motion to adjourn the meeting and with a second from Supervisor Stebane, motion was carried.
